### ORDINANCE NO. 2010-4007

Passed December 6, 2010

**AN ORDINANCE TO MAKE APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES OF THE CITY OF PATASKALA, STATE OF OHIO, FOR THE YEAR ENDING DECEMBER 31, 2011 AND TO ACCEPT THE CITY OF PATASKALA 2011-2013 NON-COLLECTIVE BARGAINING EMPLOYEE PAY MATRIX EFFECTIVE FOR THE FIRST PAY PERIOD BEGINNING JANUARY 1, 2011**

**WHEREAS**, the City Council is authorized to adopt the Municipal Budget for the year beginning January 1, 2011 and ending December 31, 2011; and

**WHEREAS**, pursuant to Section 5.04 of Article V of the Charter of the City of Pataskala, Ohio, the City Administrator has submitted a proposed municipal budget with estimates and explanatory data; and

**WHEREAS**, such revision is in the public interest of the City of Pataskala and it's non-collective bargaining personnel.

**WHEREAS**, Section 3.01(A)(4) of the Charter of the City of Pataskala authorizes Council to establish the rate of compensation for non-collective bargaining personnel public employees of the City by Ordinance or Resolution; and

**WHEREAS**, the City Administrator of the City of Pataskala recommends that the City of Pataskala 2011-2013 non-collective bargaining personnel Employee Pay Matrix be established; and

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PATASKALA, LICKING COUNTY, OHIO, A MAJORITY OF THE MEMBERS CONCURRING, THAT:**


**SECTION 1.** To provide for the current expenses and other expenditures of the City of Pataskala during the year ending December 31, 2011, the following sums as specified in Exhibit "A", attached hereto and incorporated herein, be and are hereby set aside and appropriated.


**SECTION 2.** The City of Pataskala 2011-2013 non-collective bargaining Employee Pay Matrix is hereby revised and limited to reflect eligible non-collective bargaining employees step increases (including eligible non-collective bargaining 2010 step increases not authorized during calendar year 2010) and modifications to the Director of Public Services, Council Clerk, Mayor's Court Clerk, and Police Clerk step and salary sequence as specified and attached hereto as Exhibit "A" and incorporated herein, for all eligible non collective bargaining employees with the City of Pataskala, County of Licking, State of Ohio effective the first pay period effective January 2011.

**SECTION 3.** Step increases for 2011 non-collective bargaining personnel and modifications to the Director of Public Services, Council Clerk, Mayor's Court Clerk, and Police Clerk step and salary sequence shall be implemented consistent with each eligible employee's seniority date (employment anniversary date) as indicated on Exhibit "A" effective the first pay period effective in January 2011.


**SECTION 4.** This Ordinance shall take effect at the earliest time provided by the laws of the State of Ohio and the Charter of the City of Pataskala.
