RESOLUTION NO. 2010 - 003

Passed February 16, 2010

A RESOLUTION SUBMITTING AN ORDINANCE PROPOSING TO LEVY BEGINNING JULY 1, 2010 A ONE PERCENT (1.0%) MUNICIPAL INCOME TAX TO THE ELECTORS OF THE CITY OF PATASKALA FOR APPROVAL AT THE MAY, 2010 PRIMARY ELECTION AND DIRECTING THE LICKING COUNTY BOARD OF ELECTIONS TO CONDUCT THE ELECTION.

WHEREAS, Article VIII, Section 8.01 of the Charter of the City of Pataskala provides that Council shall not adopt a municipal income tax unless the income tax is approved by a majority vote of the electors voting on the issue; and

WHEREAS, the Council of the City of Pataskala specifically finds that it is necessary to levy an income tax to provide funds for the purpose of general municipal operations, maintenance, new equipment, extension and enlargement of municipal services and facilities, and capital improvements; and to supplement revenue already available for such purposes, on all salaries, wages, commissions and other compensation earned by residents of this municipality; on all salaries, wages, commissions and other compensation earned by nonresidents of this municipality; for work done or services performed or rendered in this municipality; on the net profits earned on all businesses, professions or other activities conducted by residents of this municipality; on the net profits earned on all businesses, professions or other activities conducted in this municipality by nonresidents; and on the net profits earned by all corporations doing business in this municipality as the result of work done or services performed or rendered in this municipality; requiring the filing of returns and furnishing of information by employers and all those subject to said tax; imposing on employers the duty of collecting the tax at the source and paying the same to this municipality; providing for the administration, collection and enforcement of said tax; declaring violation thereof to be a misdemeanor and imposing penalties thereof; and

WHEREAS, the Council of the City of Pataskala has approved Ordinance 2010-3959 providing for and beginning July 1, 2010 a one percent (1.0%) TAX on income and hereby Council desires to submit this Ordinance to the electors of the City of Pataskala for a vote at the May, 2010 Primary Election.


NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF THE MEMBERS ELECTED THERETO CONCURRING THAT:


SECTION ONE. This Council hereby directs the Licking County Board of Elections to submit to the electors of the City of Pataskala, Ohio, at the May, 2010 Primary Election the question of approving the enactment of Ordinance 2010-3959 providing for and beginning July 1, 2010 a one percent (1.0%) TAX on income for the purposes of general municipal operations, maintenance, new equipment, extension and enlargement of municipal services and facilities, and capital improvements of the municipality, a copy of which Ordinance is attached hereto and incorporated herein by reference as if fully rewritten.



SECTION THREE. This Resolution shall take effect at the earliest time provided by the laws of the State of Ohio and the Charter of the City of Pataskala.


