



CITY OF PATASKALA

SPECIAL COUNCIL MEETING

May 24, 2010

The Council of the City of Pataskala met in special session on May 24, 2010 at 6:30 PM at City Hall, located at 621 W. Broad Street. The pledge of allegiance was given. Roll Call: Brush, King, Lenzo, McKinstry, Sagar, and Triplett-present. Raybourne was absent. Mayor Stephen J. Butcher presiding and Rufus B. Hurst, Law Director was present.

Citizens Comments

Mike Fox provided public comments and these comments are available by audio recording through the Office of the Clerk of Council.

Mayor Butcher stated, "The purpose of this Special Meeting is for the discussion, consideration, and adoption of Ordinance 2010-3974 as an emergency measure which is an ordinance authorizing the City Administrator to execute an agreement for participation with the Regional Income Tax Agency (RITA) for services relating to the administration, enforcement and collection of the City of Pataskala Income Tax and also to dispense with the readings and to take action to adopt Ordinance 2010-3975 an ordinance to amend Ordinance Number 2010-3969 making appropriations for current expenses and other expenditures of the City of Pataskala for the year ending December 31, 2010, increasing, decreasing and transferring funds."

McKinstry made a motion to have the second reading of Ordinance 2010-3974. Seconded by Triplett. The Clerk read the following:

ORDINANCE 2010-3974 Second Reading An ordinance authorizing the City Administrator to execute an agreement for participation with the Regional Income Tax Agency (RITA) for services relating to the administration, enforcement and collection of the City of Pataskala Income Tax.

Discussion was regarding RITA's review of the City Income Tax and the timing of the collection.

Triplett made a motion to amend Ordinance 2010-3874 by substitution to include all necessary emergency language for immediate passage. Seconded by Sagar. Roll Call: King, Lenzo, McKinstry, Sagar, Triplett, and Brush-yes. Mayor Butcher declared the motion passed.

Triplett made a motion to declare Ordinance 2010-3974 an emergency which is necessary for the preservation of the public peace, health and safety of the inhabitants of the City of Pataskala in order to provide for income tax administration, enforcement, and collection services from Regional Income Tax Agency as an experienced agency. Seconded by Lenzo. Roll Call: Lenzo, McKinstry, Sagar, Triplett, Brush, and King-yes. Mayor Butcher declared the motion passed.

McKinstry made a motion to adopt Ordinance 2010-3974. Seconded by King. Roll Call: McKinstry, Sagar, Triplett, Brush, King, and Lenzo-yes. Mayor Butcher declared the motion passed.

McKinstry made a motion to have the second reading of Ordinance 2010-3975. Seconded by Lenzo. The Clerk read the following:

ORDINANCE 2010-3975 Second Reading An ordinance to amend Ordinance Number 2010-3969 making appropriations for current expenses and other expenditures of the City of Pataskala for the year ending December 31, 2010, increasing, decreasing and transferring funds.

Triplett made a motion to dispense with the readings of Ordinance 2010-3975 on three separate dates as provided for in Section 4.01 of the Charter of the City of Pataskala. Seconded by Lenzo. Roll Call: Sagar, Triplett, Brush, King, Lenzo, and McKinstry-yes. Mayor Butcher declared the motion passed.

Triplett made a motion to adopt Ordinance 2010-3975. Seconded by McKinstry. Roll Call: Triplett-yes, Brush-no, King-yes, Lenzo-yes, McKinstry-yes, and Sagar-yes. Mayor Butcher declared the motion passed.

There were no additional Citizens Comments.


