ORDINANCE NO. 2010 - 3960

Passed January 19, 2010

AN ORDINANCE OF THE COUNCIL OF THE CITY OF PATASKALA REQUESTING THE LICKING COUNTY AUDITOR TO CERTIFY TO THE CITY THE TOTAL CURRENT TAX VALUATION OF THE CITY AND THE DOLLAR AMOUNT OF REVENUE THAT WOULD BE GENERATED BY LEVYING A PERMANENT SEVEN MILLS (7.00) FOR CURRENT EXPENSES

Whereas, the Council of the City of Pataskala, which is the taxing authority of the City of Pataskala, finds that the amount of taxes that may be raised within the ten-mill limitation will be insufficient to provide for the necessary requirements of the subdivision and that it is necessary to levy in excess of that limitation for current expenses of the City pursuant to Sections 5705.19(A) Revised Code; and

Whereas, Council is hereby acting pursuant to Sections 5705.03 and 5705.05 of the Revised Code to request the Licking County Auditor to certify certain information to the City in connection with a proposed permanent levy of 7.00 mills;

NOW THEREFORE, BE IT ORDAINED, BY THE COUNCIL OF THE CITY OF PATASKALA, LICKING COUNTY, OHIO, BY VOTE OF A TWO THIRDS MAJORITY OF ALL MEMBERS ELECTED THERETO CONCURRING:

Section 1. The Licking County Auditor is hereby requested to certify to the City the total current tax valuation of the subdivision (the City of Pataskala), and the dollar amount of revenue that would be generated by a permanent additional 7.00 mill levy to be levied by the City of Pataskala for the current expenses of the City.

Section 2. The proposed additional 7.00 mill levy is for the purposes set forth in Section 5705.19(A) of the Revised Code, and specifically the purposes are as follows:


For current expenses of the subdivision

Section 3. The amount of the proposed additional permanent levy is seven (7.00) mills on each one dollar of tax valuation. The levy shall be voted on at the election to be held on May 4, 2010, and the levy shall be a levy upon the duplicate of the tax year beginning January 1, 2010. Effective tax year beginning January 1, 2010, the City shall continuously levy an amount not to exceed seven (7.00) permanent mills (tax year 2010, collection year 2011) which shall be used for current expenses of the City.


Section 4. The Clerk is hereby directed to certify this Ordinance to the Licking County Auditor.

Section 5. This Ordinance shall take effect at the earliest period allowed by law.
